*Ms Hannele Arvonen* holds a Master's degree in forestry from Helsinki, Finland, and a Bacherlor's degree in international relations from Wisconsin. She is the CEO of the Swedish, state owned company Sveaskog, which is Sweden's largest forest owner. Before joining Sveaskog, Hannele worked for several Swedish paper and forestry companies. (Hannele Arvonen can unfortunately not participate).

**Professor Eeva Primmer** has a PhD in Agriculture and Forestry and is Docent (Adjunct Professor) in environmental policy at the University of Helsinki. She is the Research Director of the Finnish Environment Institute, SYKE, a sustainability advancing multidisciplinary and transdisciplinary research organisation. Her expertise lies in policy and governance of forests, biodiversity and ecosystem services.

**Professor Peter Sandøe**, Denmark, is a philosopher with a DPhil from Oxford University. He has been professor of philosophy in Copenhagen since 1994. For 30 years, his research has focused mainly on bioethics, with emphasis on ethical issues related to animals, biotechnology and food production. He is committed to interdisciplinary work combining perspectives from natural science, social sciences and philosophy. He has served on many national and international committees and is convinced that research must benefit society.

*Dr Anthony Simons* was raised in New Zealand and after his Bachelors' Degree moved to the UK. He got his PhD in forest genetics at Cambridge University before joining Oxford University as a Research Fellow on tropical forestry. To follow his two interests of science and development, 26 years ago he joined ICRAF in Kenya as a scientist. He is now the Executive Director of CIFOR-ICRAF which is a centre of science and development for agroforestry, forestry and landscape restoration. He is based in Nairobi, Kenya – and works in Asia, Latin America and Africa. Anthony (aka Tony) is passionate about the positive roles that private sector and private investors can play in development and wise environmental stewardship.

*Mr Andy Wiltshire* grew up in New Zealand, where he studied forestry and later earned an MBA degree. He worked with forest management in state owned and privately owned forest companies for two decades before moving to the US. He has since worked as a forester and businessman, specializing in global investments in agriculture and forestry. He has moved back to his home country and now shares his time between New Zealand and the USA.
